MOTION: Lawrence Coultas moved and Jeff Pittman seconded to pay bills as presented with a few questions being asked of office personnel. Roll call resulted 5 yeas and 1 abstention. Bill Jacquot abstained. Motion carried.

MOTION: Lawrence Coultas moved and Terry Gregory seconded to approve and dispense with the reading of the minutes from the previous meeting with some grammatical corrections. Roll call resulted in 4 yeas and 2 abstentions. Ron Bell & Bill Jacquot abstained. Motion carried. Errors will be corrected and sent to council members.

Freddie Andrews, Fire Chief stated December was the start of a new year for his department and gave an update. At the present time no money is needed. The new lights on the trucks are awesome and he thanked the council for them. There were 34 fire calls up 10 from last year. Andrews said they need to start looking at a pumper truck in the near future. ISO rating was done in October. Some fire records were burnt in the Marshall fire last year.

Ron Bell stated Randy Ford said he wasn't aware of the fire practices with the fire department using a lot of water. He gets an alert on his phone when the water is low. They plan to do a practice burn in the country but will use rural water. The new radios are working fine. Lawrence Coultas asked how many firemen they can have on the roster. Since it is a volunteer crew they can only have 20 members. He has 2-4 on a waiting list.

Amy Brown, City Treasurer asked City Attorney Coonrod if they needed to send out an invoice for the grant on the sidewalks. The city is trying to do their best with the outflow of cash. Brown said the TIF was up and she thinks it will double.
